

## CMF sanctions Issuers of Publicly Offered Securities for breaching ongoing information duties

*42 entities failed to submit their financial statements in a timely manner.*

**January 3, 2025** — The Board of the Financial Market Commission (CMF) sanctioned 42 Issuers of Publicly Offered Securities (EVOPs, for their Spanish acronym) for breaching their ongoing information duties.

Pursuant to Exempt Resolution No. 12,095, these entities infringed upon the instructions set forth in General Rule No. 30 by not submitting their financial statements in a timely manner. Said information allows both the CMF and the public to have updated data showing issuers' real financial situation to both supervise and take informed decisions, respectively.

According to Decree Law No. 3,538 and other complementary regulations, these investigations were conducted through a simplified sanctioning procedure which allows, among other things, admission of responsibility by sanctioned parties.
